Education and Qualifications:

Giulio Bartolini is Associate Professor of International Law at the Department of Law, University of “Roma Tre”. He is also Director of the Roma Tre International Humanitarian Law Legal Clinic. LL.M. in Political Science (Siena), PhD in International and European Law (La Sapienza University, Rome), Prof. Bartolini was also awarded the Diploma of the Academy of European Law, European University Institute (Human Rights Session).

Academic Activities:

Prof. Bartolini is Editor-in-Chief of the Yearbook of International Disaster Law (Brill) and managing editor of the e-journal ‘Questions of International Law’.

He lectures at the Geneva Academy of IHL and HRs and has been responsible of the ‘Doctoral Networking Sessions’ at the Hague Academy of International Law (Winter Session and Summer Session 2019, Summer Session to be held in 2022). He has been visiting professor/researcher in several institutions, including the European University Institute, Fernand Braudel Senior Fellow; Paris X Centre de droit international de Nanterre; Paris 2 Panthéon-Assas; Leiden University, Grotius Center for International Legal Studies; British Institute of International and Comparative Law; Lauterpacht Centre, University of Cambridge. He has been recipient of several grants as Jean Monnet Project, Jean Monnet Module, KA2 Erasmus Plus and agreements with IFRC. Speakers in several international conferences, including annual meetings of ASIL and ESIL (twice both) and author/editor of several volumes/articles with OUP, CUP, Brill, Routledge, Bruylant, EE.

Cooperation with relevant institutions:

Prof. Bartolini is Member of the National IHL Commission established by the Italian Ministry of Foreign Affairs. He is President of the Committee of Expert, Section International Humanitarian Law, of the Italian Red Cross and has acted as legal adviser for this National Society at the 32nd and 33rd International Conference of Red Cross and Red Crescent (2015, 2019) and in several international meetings.

As Director of the Roma Tre IHL Legal Clinic Prof. Bartolini has managed several projects and desk studies on behalf of the ICRC, NATO SHAPE Allied Command Operations Legal Office, CoeSPU, Amnesty International, the IFRC, the Italian Red Cross, the Rome Military Tribunal.

Responsible of multiple initiatives on international disaster law (courses with the Sanremo IIHL and IFRC, former legal adviser to the UN ILC Special rapporteur on the protection of persons in the event of disasters, etc.). He collaborates with the Italian Armed Forces on a regular basis and is a full member of the International Institute of Humanitarian Law, Sanremo and acted as “Course Director” in IHL courses organized with the Ministry of Defence of Montenegro and Albania. Member of the ‘core expert group’ for the Oxford Guidance on the Law Relating to Humanitarian Relief Operations in Situations of Armed Conflict (University of Oxford/OCHA).
